This position is responsible for assisting the Military and Veterans Resource Coordinator in the Gateway.

- 50% - Assist and participate in outreach within the community and with on-campus efforts and events as needed. (Ex: Set up/tear down, supplies inventory status and pack/prepped). Work collaboratively with the OSU Newark campus veteran mentor as needed. Maintains monthly calendar of student Veterans and Military events including workshops, lounge maintenance etc.
- 20% - Provide customer service to students, staff, and community members. Additional time may be spent connecting with VA Certifying Official and Student Life as needed. Outreach to Veterans and Military applicants. Assist Admissions with outreach to applicants indicating Veteran, Military, Military Connected.
- 15% - Network with local businesses and community agencies and organizations regarding established programs, new outreach initiatives, and exhibitions.
- 10% - General Office as needed: Emails-Phone calls- Mailings.
- 5% - Other duties as assigned.
