Addiction Studies Certificate

The number of citizens affected by substance use disorder is in the millions and Ohio is severely affected. The Addiction Studies Certificate program prepares individuals to work in an entry-level position in many community health programs. Coursework includes training in how to assist individuals and families with a variety of issues arising from addiction problems.

The opiod crisis is overwhelming our communities and those agencies providing services. A more qualified employee at all levels of these organizations would be highly desirable.

The Addiction Studies Certificate is set up to auto-award a certificate on the Human Services AAS track for those students choosing the Chemical Dependency II elective course. This certificate option is available to any COTC student from other disciplines that interact with substance abuse clients or related addiction issues.

Students seeking the Addiction Studies Certificate may also be interested in pursuing an Associate of Arts degree with a focus in Social Work, Criminal Justice, or Psychology.

Learning Outcomes

At the completion of the certificate the student will have:

- A comprehensive understanding of the field of addiction, including its diagnosis and treatment.
- Enhanced ability to communicate with and interact with those affected by addiction.
- Awareness of culturally relevant prevention and education initiatives.

Career Opportunities

Students completing the two Human Services chemical dependency courses or this full certificate option are eligible to take the CDCA certification for credentialing as an Ohio Chemical Dependency Counselor Assistant. http://ocdp.ohio.gov.

Graduates are prepared to work in a variety of entry-level positions in the addiction/ substance abuse field to help meet ever-increasing needs for addiction counselors in Ohio.

- Chemical Dependency Counselor Assistant (must meet Ohio licensing requirements)
- Licensed Chemical Dependency Counselor II (must meet Ohio licensing requirements)
- Addiction Counselor
- Caseworker
- Mental Health Aid
- Probation Assistant

According to the U.S. Bureau of Labor Statistics, employment for addiction/ substance abuse counselors is expected to increase by 31 percent through 2022. Starting salary is projected at \$21,000—24,000 annually.
