Case Management for the Healthcare and Gerontology Professional Certificate

Case managers are employed in a variety of settings. They provide client services, including support for families, in a wide variety of fields including behavioral health, rehabilitation, social work agencies, public health agencies, forensics and addiction services. They assist other workers such as social workers, and help clients find benefits or community services. Case managers may also find employment in nonprofit organizations, for profit social service agencies, and state and local government. This certificate entails a generalized case management course and additional courses that focus on healthcare and gerontology work settings.

Graduates are awarded a Certificate of Completion in the Case Management for Healthcare and Gerontology Professional Certificate program.

Registered Nurses or Licensed Practical Nurses may complete this additional education to assist them in case management roles in patient care settings. Students completing this certification may later choose to pursue career paths in nursing or human services, complete the Associate of Applied Science in Health Services Technology, or combine the certificate with other certificates such as the Community Health Worker to improve employment options.

Learning Outcomes

At the completion of the plan of study the student will have:

- A generalized understanding of case management.
- Demonstrate casemanagement skills,

including documentable assessment, treatment planning, crisis intervention and ability to make appropriate referrals.

- Enhanced ability to communicate and interact in healthcare and gerontology settings.
- Sensitivity when working with diverse populations.

Career Opportunities

The US Bureau of Labor Statistics notes that employment of nurses is expected to grow by 16% and employment of social workers by 12% between 2014 and 2024, two occupational groups that may include case managers. Occupational outlook information from the Commission for Case Manager Certification (CCMC) reports that the need for qualified case managers is expected to grow in order to address the increasing elderly population, a growing number of patients suffering from chronic illness, and the impact of managed care and additional regulation. Therefore, employment opportunities appear promising.
