FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

They include the right to: 1) inspect and review these records; 2) request an amendment to the records; 3) consent to or restrict disclosures of personally identifiable information in the records; and 4) file a complaint with the U.S. Department of Education concerning the College's alleged failure to comply with FERPA. A student convicted of possessing or selling drugs after the FAFSA is submitted, and while receiving Federal Financial Aid, must notify the Office of Financial Aid immediately at Hopewell Hall, 1179 University Drive, Newark, Ohio 43055; phone (740) 366-9435; or email finaid@cotc.edu. In general, if convicted of a drug-related felony or misdemeanor that took place while receiving Federal Student Aid, the student will become ineligible to receive further aid for a specified period of time upon conviction.
