Degree/Program: Associate of Applied Science (AAS) / Criminal Justice Technology

Target Institution: University of Cincinnati / College of Education, Criminal Justice, and Human Services (CECH)

Degree/Program: Bachelor of Science (BS) / Criminal Justice (CJ) (On-Campus & Online)

Modality: On-Campus or Online

Introduction: This agreement details the applicability of courses from the Central Ohio Technical College AAS Criminal Justice Technology to the BS CJ in the UC CECH. Students who complete the AAS Criminal Justice Technology at Central Ohio Technical College have partially satisfied the UC Criminal Justice General Education requirement.

Articulation Overview: Graduates from Central Ohio Technical College who have followed the prescribed program and are accepted into CECH will enter with 59 hours of transfer credit applicable toward the BS CJ degree.

Admission Criteria: *Note: completing the courses on the appendices below does not guarantee admission to the UC BS CJ program.

Minimum GPA: 2.0

BS Completion: Completion of this program may require more than four semesters to complete due to prerequisite requirements and the order in which required courses must be taken and are offered. UC academic advising staff will work with each transfer student to develop the most expedient pathway to graduation.

Admission Period: Central Ohio Technical College students must be admitted to the UC CECH during the duration of this agreement (i.e. between August 2023 and July 2026).

Agreement Execution Date: August 2023

Agreement End Date: July 2026

EXECUTION, DURATION AND REVIEW OF AGREEMENT:

This agreement becomes effective upon its signing by the Deans of both Colleges and will remain effective for the duration of the agreement noted above. At the end of this time, the agreement will be reviewed and may be renegotiated. Central Ohio Technical College and CECH agree to keep one another informed as program changes affecting the agreement occur. The Deans of both Colleges will agree upon any future additions and/or amendments to this document in writing.

This agreement will be reviewed on an annual basis and is subject to change due to revisions in program curriculum.

Central Ohio Technical College students are encouraged to work closely with their academic advisor to monitor possible changes.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, The University of Cincinnati (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us.
