#### **NEW BUSINESS**

#### Board Rules amendments – Dr. Jackie Parrill

Dr. Parrill explained the reasons behind the amendments for two board rules and asked for consideration of these changes.

3357:3-1-01 Membership, duties, and powers of the BOT

3357:3-1-03 Meetings and Committees of the BOT

Ms. Sutton made a motion to approve the board rules amendments as presented and Mr. Hawkins seconded the motion. Motion passed.

**BE IT RESOLVED:** The recent passage of House Bill 33 transfers local trustee appointing power from school districts to a trustee selection committee selected by the boards executive committee, allows trustees to continue to serve in office until the trustee's successor takes office, and clarifies the quorum requirement to equal a majority of the current sitting board, instead of a majority of the statutory membership of the board. In accordance with Ohio Revised Code 3357.09, the COTC Board of Trustees approves the amendment to board rules 3357:3-1-01 - Membership, duties and powers of the board of trustees and 3357-3-1-03 – Meetings and committees of the board of trustees.

## Development of Semiconductor Programs submission approval – Lauren Massie

Lauren Massie, Dean of Technical Studies informed the board that COTC has partnered with OACC to develop training aligned to Intel and other area manufacturing needs in the semiconductor industry and within our three-

county service area. The courses have been developed by this statewide consortium so we are sharing curriculum across the state. We received a \$15,000 grant to finalize courses by December 2023. Ms. Massie shared plans of study for two options we'd like to offer at COTC (short-term certificate and degree program). Both will prepare graduates for entry level technician positions within the semiconductor manufacturing industry. Ms. Massie asked for approval and authorization to submit our application to the ODHE as the next steps for program approval.

Mr. Hawkins made a motion to authorize the development of an Associate of applied Science degree and certificate in Semiconductor Manufacturing Engineering Technology to be offer by COTC and gives permission for the college to submit the application to the Ohio Department of Higher Education. Mr. Guanciale seconded the motion passed.

**BE IT RESOLVED:** The Central Ohio Technical College Board of Trustees authorizes the development of an Associate of Applied Science degree and certificate in Semiconductor Manufacturing Engineering Technology to be offered by Central Ohio Technical College and does authorize the college to submit the application to the Chancellor at the Ohio Department of Higher Education.
