#### **OLD BUSINESS**

<u>ORC Section 3357.05 Appointment of board of trustees</u> Dr. Berry shared information about the difference in how our trustees are appointed to the board according to the Ohio Revised Code and shared information about board terms.

Ms. Sutton, Chair of the Board Development Committee explained how the process of appointing trustees will change effective January 2024 and shared a list of candidates for the TSC begin considered.

#### **Board Development Committee**

Mr. Montagnese announced that there are two individuals up for re-appointment on the NCDF board. Short bios were provided in the board packet.

Mr. Hawkins made a motion to appoint Douglas F. Mock to serve a three-year term as a trustee of the Newark Campus Development Fund, which will expire December 31, 2026. Mr. Guanciale seconded the motion. Motion carried.

#### **Defining and Combating Antisemitism**

Dr. Parrill added to the college's non-discrimination policy. A copy of the executive order was included in the board packet. Because of the continuation of discrimination on campuses they have asked colleges to adopt such policies. Adopting this will bring us into compliance.

Dr. Law made a motion to adopt the IHRA's working definition of Antisemitism as outlined below. Ms. Snyder seconded the motion. Motion carried.

**BE IT RESOLVED:** in accordance with Executive Order 2022-06D – Defining and Combating Antisemitism, the COTC Board of Trustees adopts the International Holocaust Remembrance Alliance's Working Definition of Antisemitism for use in determining violations of policy or regulations prohibiting discriminatory acts. The

definition is as follows, "Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."
