

DMS Program Accreditation

Program is accredited by the Commission for the Accreditation of Allied Health Education Programs, overseen by the Joint Review Commission on Education in DMS.

Graduates of the DMS program are eligible to sit for the National Credentialing/Registry Examinations

 - American Registry of Diagnostic Medical Sonographers

- The majority of COTC DMS graduates earn their credentials PRIOR to graduation.
- Certification/credentials are national for Sonographers.
 - Once you earn you credentials, you can work in any state.

Program Prerequisite Courses

MATH 140 College Algebra (preferred) or College-Level Math

PHYS 105 Elementary Physics

DMS APPLICATION REQUIREMENTS

- Apply for admission to COTC (no application fee)
- Complete remedial coursework (if required)*
- Submit official high school transcript or GED and transcripts
 - ALL colleges/universities or adult education programs
- Attend Health Information Meeting with Advisor (valid for 12 months)
- Atteria Health Information Meeting with Advisor (valid for 12 months

Complete SONOGRAPHY INFORMATION COURSE Online on DMS website

- Complete required program prerequisite courses*
- Take the HESI exam (scores valid for 12 months)
- Submit online DMS application by application deadline

*courses can be in progress spring semester of the deadline



Transcripts

Must have all final official transcripts on file prior to submitting DMS application.

 High school or GED and <u>all</u> previously or currently enrolled postsecondary institutions including colleges and career centers (official transcripts must be in a school sealed envelope or sent electronically directly to COTC Records).





Transcripts

- Students who completed College Credit Plus or Post-Secondary courses while in high school must request transcripts from the College providing credit.
- Students who attended multiple institutions must request a transcript from each institution attended.
- Students who withdrew from a college before completing any courses must verify if they have a transcript on file. If so, they must request a transcript.





Transcripts

- Students with continuing education credit or employment training provided through a college must request a transcript.
- Students who attended a permanently closed institution will still need to provide a transcript. Please visit the Ohio Department of Education website for information on how to request from a closed institution.
- International high school and college transcripts must be evaluated by a current member of NACES (www.naces.org) and an official report must be sent directly to COTC Records.
- Students who are unsure of past institutions they have attended may view their educational attendance history through the National Student Clearinghouse – https://www.studentclearinghouse.org

HESI A2

Health Education Systems, Inc.

- Valid for 12 months
- Current cost is \$50 and is administered at COTC, offered on ALL campuses
- HESI A2 exams will only be available in-person
- COTC does NOT offer remote-online exams
- No minimum score needed to apply to program
- Scores are automatically sent over to records
- MOST RECENT scores used for application
- Study guide materials, including practice exams are available on the HESI webpage

- Test must be completed by program application deadline

Health Education Systems, Inc.

Transfer from or taking at another location?

- Scores can be sent from any testing location as long as they meet the following criteria:
 - -It must be administered in-person. No remote exams will be accepted.
 - -The test must have *exactly* the same subjects our HESI A2 covers **no more, no less**.

Subject Areas:

- 1. Reading Comprehension
- 2. Vocabulary & General Knowledge
- 3. Basic Math Skills
- 4. Biology
- 5. Chemistry
- The score transcript must be ordered from HESI and sent directly to <u>cotcrecords@mail.cotc.edu</u> to be verified.

Sonography Information Course

After you have completed the short online Sonography Information Course:

You will complete the form/questionnaire in the link provided at the end of the course



Your information and documentation of completion will automatically be sent to the COTC GATEWAY.



The DMS Program courses are lockstep, meaning they must be taken in a specific order

The majority of DMS courses are daytime

Very few DMS courses are online and/or offered in the evening

You may take any of the <u>General Education courses</u> listed on the DMS plan of study at any time, any semester, in any format available, and on any campus

If selected, especially in the 2nd & 3rd years of the program, students will need to plan life and work around program schedule.

On campus 2 days a week and in clinical 3 days a week



Application Deadlines

- ✓ APPLICATION DEADLINE for DMS is May 1
- ✓ Applications available one month prior to deadline. Request from your assigned advisor or email cotcadvising@mail.cotc.edu
- ✓ If eligible, your advisor will email you an application link. Your application will be submitted online.
- Incomplete applications and requirements will not be accepted or reviewed.

Selection Criteria

- GPA: Blended High school/ College GPA
- HESI exam scores

Blind Selection Process
Students are ranked and the top students are offered a seat



Selection Facts



- It is advised that students apply to both programs (General & Cardiovascular)
- You can designate your 1st choice vs. 2nd choice on the DMS application

Approximately how many are selected?

General: 10 students

Cardiovascular: 12 students



What Happens After Applying?

All applicants will be notified of selection via **COTC** email approximately **4 weeks** <u>after</u> the application deadline

*June

SELECTED STUDENTS will attend a <u>MANDATORY</u> DMS Orientation Meeting (Late July or Early August)

Failure to attend orientation will <u>FORFEIT</u> your seat

NON-SELECTED STUDENTS:

Please meet with your advisor to discuss a plan of action / re-application
 Always have a Plan B

SELECTED STUDENTS After orientation meeting:

- 1) Selected students will be required to complete a Nationwide FBI & BCI Background checks
 - Fee (1 copy for college, 1 mailed to you)
 - No Felonies / Some Misdemeanors may also disqualify (will handle case by case)
- 3) Selected students will be required to complete a Drug Screening
 - Fee
 - Zero tolerance policy
