OSUN Board Report

Ms. Houdeshell reported on Ohio State's Academic Plan

Ohio State's Provost Melissa Gilliam presented the Academic Plan at September's University Senate meeting, and Dean Bill MacDonald has been working with the Vice Provost on the process we will used to align our campus's vision and priorities with the Academic Plan. The plan's operational-excellence goal calls us to align our academic, administrative, and business processes with those of OAA and other university units, and to perform deeper analyses of our operations to enchance performance and academic excellence. That work will guide not only our long-term financial planning, but also our near-term financial planning, which will be critical to dealing with the loss of revenue associated with our enrollment decline and avoiding a budget deficit next year. After three consecutive years of enrollment declines, our enrollment has fallen to less 2,300 students. The last time enrollment was less than 2,300 students was 2005.

NCDF Board Appointments

Mr. Montagnese reported that the NCDF board wishes to renew two trustees, Randall Anstine and Robert O'Neill both for three-year terms beginning January 1, 2023 with terms expiring on December 31, 2025.

New Program: Respiratory Therapy Technology

Dr. Parrill asked for approval to develop and implement this new program at the request of our healthcare partners due to a shortage in this field. With the anticipated growth in this area, the college has developed a plan of study in compliance with accreditation requirements. We will need to hire a new faculty who will also serve as the program director in this area. Perkin funds will be used to support this program initially.

Ms. Sutton made a motion to approve. Ms. Warnock seconded the motion. Discussion followed. Motion passed.

BE IT RESOLVED: The Central Ohio Technical College Board of Trustees approve the Respiratory Therapy Technology (RT) Associate of Applied Science degree program as presented.
