COMMITTEE REPORTS – Audit Finance

Mr. Thompson and Dr. David Brillhart offered the following comments:

COTC Financial Statements for the period ended March 31, 2023

- As a reminder, our FY23 budget included a transfer from reserves of \$1.7m. This represents our first year of budgeting with a deficit utilizing our \$6 million dollar reserve (enrollment stabilization fund).
- Our enrollment for the year reflects a further decline from budgeted levels by about 12% in fte. This would result in about \$1.2m additional tuition loss.
- Due to the additional enrollment decline, the college took some mid-year personnel actions eliminating several vacant staff and faculty positions. These actions combined with conservative spending and the transfer in of \$1.7m should allow the college to stay on budget for the year.

FY24 Budget Update

• FY24 is the first year of the state operating biennium. Accordingly, the state budget is in development. The initial budget from the Governor was very positive for two year colleges but the House version was much more tempered. Due to the importance of the state budget to both our SSI levels and our ability to set tuition, we are waiting to the June Board meeting to bring a budget for FY24.

Mr. Thompson made a motion the board has reviewed and approve the financial report for the period ended March 31, 2023. Dr. Law seconded the motion. Motion passed.
